#### Message from the president

There Ought to be a Law! This phrase gained popularity through the comic strip *There Oughta Be A Law*, created by Harry Shorten and Al Fagaly.

However, there is nothing comical about the fact that there are <u>no laws</u> that protect animals on the farm.

In 2024, we started a campaign called "There Ought to Be a Law" (TOBL). To that end, we launched <u>e-petition</u> <u>5114</u> to the federal government asking that animals be declared sentient. The e-petition garnered 10,187 signatures and was presented to the House of Commons on November 20, 2024. The government response was due on January 4, 2025. That date was not met, and parliament was prorogued on January 6. Then on March 23, Parliament was dissolved. This means that the e-petition process must be re-started. We will do that, confident that we will have the same support from you and other animal protection organizations.

One of the issues is that animals are considered property in the criminal code. If animals are considered sentient, it is our view that cruelty to animals could be moved to a separate section of the code.

Our campaign against foie gras continues. Petitions with 3789 English signatures and 2686 French were sent to restaurants and stores that serve or market the cruel product. The current focus is consumers themselves, educating them of the realities of foie gras production.

In late 2024 we started strategic planning for the next three years, with the document to be released in June of 2025.

We are so grateful to you our donors, volunteers, and supporters who make our work possible. We wouldn't be able to do what we do without you!

#### There Ought to be a Law Campaign

If you believe animals feel love, happiness, fear, sorrow, pain...then you already know animals are sentient.

We believe there should be laws for animal protection on farms.

Unfortunately, animals are considered property in the criminal code.

Property comes under the jurisdiction of the provinces and territories, not the federal government. The provincial and territorial animal welfare acts for the most part exempt "generally accepted practices of agricultural animal care, management or husbandry". This means that piglet thumping, tail docking, taking a calf from its mother and other cruel practices are allowed. Animals on farms endure treatment that would be considered cruel if used on a companion or wild animal.

On top of that, cruelty complaints often aren't followed up on when reported.

If animals are considered sentient, it is our view that cruelty to animals could be moved to a separate section of the code.

This is why we launched the **There Ought to be a Law Campaign** in 2024 which included <u>e-petition</u> <u>5114</u> asking that animals be declared sentient by the federal government.

In our continuing campaign to have animals declared sentient, we will advocate strongly for animals to be taken out of the property section of the criminal code and put in its own section. That would mean that the federal government could make laws regarding animals on the farm.

CCFA works cooperatively with other animal protection organizations in a concerted effort to improve the lives of farm animals.



**Foie Gras Campaign** 

For foie gras production, 3-month-old ducks (who have only recently learned to quack), are immobilized in individual cages or small group pens. Then, for two weeks, long metal pipes are forced down their throats and more than 1.75 kg of food a day is pumped into their stomachs. Their livers swell up to 10 times their normal size. This not only causes extreme pain and suffering, but some die as a result. At only three months old, the ducks are sent to slaughter.

Since Montreal, Ottawa, Toronto and Vancouver are the highest consumers of foie gras, we decided to run our campaign in these cities.

We put up signs in Ottawa on transit shelters and street stands, and posters on the Skytrain in Vancouver.

We ran full-page ads in Montreal's Cult Magazine, December edition, Toronto's Grind Magazine, February/March edition, and Vancouver's Georgia Straight Magazine, February edition.

We also ran Facebook ads to raise awareness of the reality of foie gras.

We designed two petition websites – English and French – asking readers to sign our

petition, calling for an outright ban on foie gras. Our petition targeted restaurants, grocers and suppliers across Canada. We garnered 3789 English signatures and 2686 French signatures. These were sent to restaurants and stores that serve or market the cruel product.

We launched a petition on change.org urging omni hotels to take foie gras off their menus. This petition garnered 6490 signatures.

The current focus of this campaign is consumers themselves, and educating them of the realities of foie gras production.





